Investment Objective

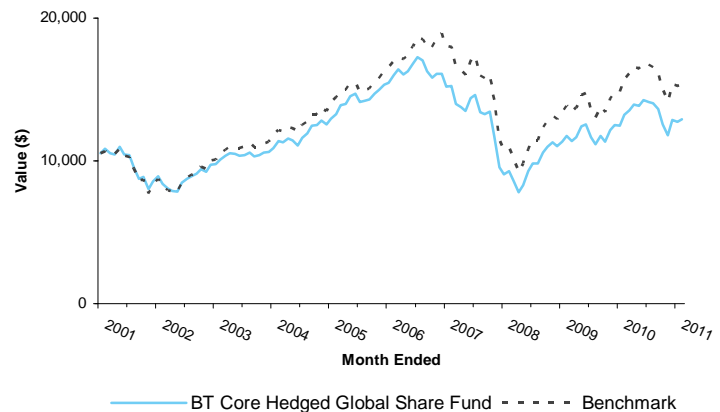

Whilst the Fund can invest in any international market that offers attractive opportunities, most investments will be located in the United States, Europe and Japan.

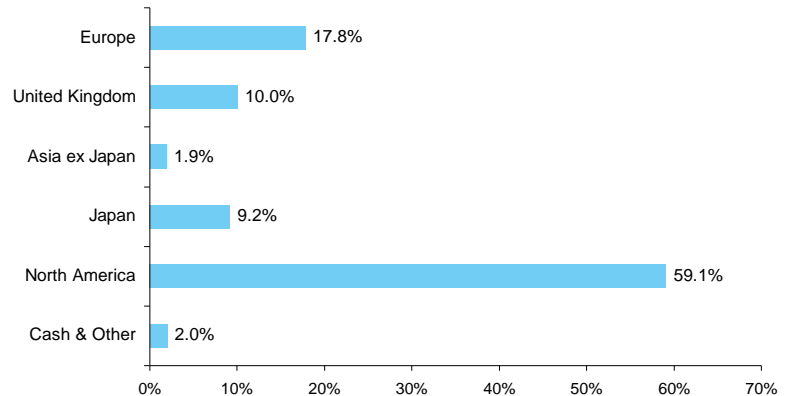

Progress of the Portfolio Investment

Fund performance

The fund performed strongly over the December 2011 quarter to outperform its benchmark. Stock selection contributed well to fund returns, with positive returns sourced from the US, continental European, Canadian and Japanese stock markets. Within the UK, stock selection was flat over the period. At an industry level, the fund is underweight in Financials and this was the largest contributor to quarterly returns.

Market outlook

Overall, the final quarter of 2011 saw global equity markets recover from a very weak prior third quarter. The MSCI World Ex Australia Accumulation Index in hedged terms was up 8.9%. Unhedged Australian global equity investors fared less well. The relative strength of the Australian dollar saw unhedged returns of only 2%. Asian markets joined the global rally despite renewed concerns around Chinese growth. The major exception was Japan, posting a negative quarter with the Nikkei down nearly 3%. Going into 2012, the fund continues to be positioned more defensively than it would normally be. Valuation differentials between lower and higher quality companies remain tight in continental Europe and Japan, though we are finding there are more relative value opportunities in the US and UK and we enter 2012 mildly overweight within these markets.
