

Additional fee information – BT Investor Choice Funds

The Product Disclosure Statement (PDS) for BT Investor Choice Funds contains information regarding the fees payable for investors in the Funds, and should be read in conjunction with this additional fee information.

When we can introduce new fees not currently charged

The constitutions of the funds may provide that we can charge the fee below. The fees that are permissible and the maximums allowable differ for each Fund.

In Table 1 below, we show the fees that may be payable on funds available to investors of BT Investor Choice Funds. These fees are currently not charged. If we introduce these fees, we will give investors 30 days written notice. Additional information for each fee is shown in Table 2.
