**Appointment of new auditor for Westpac Financial Services Limited
(ACN 000 241 127) as Responsible Entity for the Managed Investment Schemes
listed in the table below.**

On 27 June 2025, Westpac Financial Services Limited (ACN 000 241 127) as the Responsible Entity of the Schemes listed below (the “Schemes”) received consent from the Australian Securities and Investments Commission for the resignation of PricewaterhouseCoopers (ABN 52 780 433 757) (“PwC”) as the statutory auditor of the Schemes for both the Financial Statements and Compliance Plans. The resignation of PwC is conditional on KPMG consenting to be appointed as the new statutory auditor for the Schemes.

The resignation of PwC, and the appointment of KPMG, as the statutory auditor of the Schemes for both the Financial Statements and Compliance Plans became effective as of 25 September 2025.

The Responsible Entity determined to appoint KPMG (ABN 51 194 660 183) as the new statutory auditor of the Schemes for both the Financial Statements and Compliance Plans following a competitive tender process, reflecting best practice for audit firm rotation.
