About this Investment Options Booklet

This is the Investment Options Booklet for BT Super Invest. BT Super Invest is part of Panorama Super, which is part of the super fund known as Asgard Independence Plan Division Two ABN 90 194 410 365.

The issuer of BT Super Invest and trustee of Asgard Independence Plan Division Two is BT Funds Management Limited ABN 63 002 916 458 AFSL 233724 ('BTFM', 'we', 'us', 'our', 'Trustee'). The administrator of BT Super Invest is BT Portfolio Services Limited ABN 73 095 055 208 ('Administrator' or 'BTPS'). The details of any relevant Distributor of BT Super Invest are set out in the Product Disclosure Statement (PDS) for BT Super Invest.

Before applying for a BT Super Invest account, it is important that you consider the PDS together with this Investment Options Booklet and the Additional Information Booklet (Booklet) for BT Super Invest. BT Super Invest is only available to investors who receive the PDS in Australia and who are over the age of 18. About the investment options

Before investing in any investment option in BT Super Invest it is important that you understand the features of that investment option. When you are considering a particular managed fund, managed portfolio option, listed security or term deposit you should ensure you read and understand (if applicable):

> the Product Disclosure Statement or relevant disclosure document and Fund Profile for the managed fund

- > the Product Disclosure Statement and Fact Sheet for managed portfolios, or
- > the terms and conditions for a term deposit.

You have a right to receive these current disclosure documents free of charge by accessing them online through your BT Super Invest account or by contacting us. Before investing you should also refer to the BT Super Invest PDS and Booklet.

Investment strategies

BT Super Invest provides a range of diversified, sectorspecific and direct investment strategies for you to choose from. The available investment options are managed funds, managed portfolios, listed securities and term deposits.

Each investment strategy has an investment objective that covers its aim, how it is normally invested and the type of investor for whom it is intended to be suitable.

An adviser can help you determine which investment

strategy is right for you and they can also help you to select the appropriate investment options within that strategy. In the descriptions of the diversified managed investment strategies set out in this Investment Options Booklet, indicative asset allocation ranges may be provided. These provide a guide to how the assets of that investment option will normally be invested by the fund manager (for managed funds) or investment manager (for managed portfolios). Actual asset allocation may move outside the indicative ranges from time to time in response to changes in economic conditions and market movements.

The Trustee may change, add or remove the investment options made available in BT Super Invest at any time. The Trustee may, in certain circumstances, also sell down an investment option that you are invested in, for example, a drawdown to maintain your minimum cash account balance. If this happens, you will be notified as soon as reasonably possible and your balance in that option may be transferred to your cash account.

Important information

Your investment in BT Super Invest is not guaranteed. The value of your investment can rise and fall depending on the investment returns achieved by the investment options you select. By participating in BT Super Invest, you are solely responsible for selecting the investment options in which you invest. The Trustee and the Administrator are not responsible for the investment options you decide to invest in and are not liable for any loss or damage you may incur as a result of you deciding to invest in, or withdraw from, a particular investment option.

Note: investment returns can be volatile and past performance is not a reliable indicator of future performance.

Fees - investment options

You should refer to the applicable Product Disclosure Statement or other disclosure document for an investment option to obtain information about fees and costs for that investment option.

Investment Holding Limits and Limit Buffers for investment options

The Trustee may impose a limit on the amount, as a percentage of your account value, that can be held in an investment option. This is referred to as an Investment Holding Limit.

If the Trustee applies an investment Holding Limit to an available investment option, you are able to invest an amount of your account value up to the Investment Holding Limit. You will not be able to invest further into an investment option if, at the time of your investment, it exceeds the Investment Holding Limit.

Monitoring of Investment Holding Limits

At least annually we will notify you (or your adviser) if you

hold an investment option that exceeds the Investment Holding Limit plus 5% of your account value, referred to as the Limit Buffer. The Limit Buffer is applied to allow for any small movements in your holdings above the Investment Holding Limit that may occur from time-to-time (e.g. market movements, withdrawals).

The applicable Investment Holding Limit for each investment option is set out in the tables of investment options in this Investment Options Booklet. Where an Investment Holding Limit is applied, a Limit Buffer of 5% applies unless specified otherwise.

Standard Risk Measure

The Standard Risk Measure is based on industry guidance to allow investors to compare investment options that are expected to deliver a similar number of negative annual returns over any 20 year period.

The Standard Risk Measure is not a complete assessment of all forms of investment risk. For instance it does not detail what the size of a negative return could be or the potential for a positive return to be less than the return an investor may require to meet their objectives. Further, it does not take into account the impact of administration fees and tax on the likelihood of a negative return.

Investors should still ensure they are comfortable with the risks and potential losses associated with their chosen investment option/s.
